|   |                |  | <p>Knowing and intentional failure to report an illegal or threatening discharge is punishable as a felony.</p> <p><b>NOTE:</b> Reporting of such information is not required when otherwise prohibited by law, or when law enforcement personnel have determined that such disclosure would adversely affect an ongoing investigation or when the information is already public knowledge within the locality affected by the discharge or threatening discharge.</p> <p>Deputy personnel shall prepare an SH-R-49 for each reported incident. District Attorney personnel shall evaluate and investigate each reported incident to determine if it meets the criteria for disclosure to appropriate agencies. All reports shall be processed with priority and forwarded immediately to the District Attorney Environmental Crimes Unit, who is responsible for making the appropriate notifications within the statutory 72-hour time limit.</p> |
