Law enforcement agency having jurisdiction over victim's residence shall take a police report and provide complainant with a copy. If crime occurred in different jurisdiction, refer the investigation to the law enforcement agency where suspected crime was committed. "Jurisdiction" means where property, goods services or medical information is received.

Ensure victim of ID compromise has copy of crime report and necessary fraud alerts/reporting made to credit bureaus/Federal Trade Commission.</p> <p>If victim company desirous of prosecution, coordinate investigation with company’s fraud investigator.</p> <p>Code 118 - Identity Theft Detail (Utilities)</p>

Identity Theft (Income Tax) 530.5(a) PC	SHR-49 URN 11	Station/Unit Detectives	Refer victim to Tax Payer Advocacy Unit. Indicate nature of income reported and dates assessed in crime report. Forward to the Internal Revenue Service or Franchise Tax Board to handle case. NOTE: "SRD" Identity Theft Detail Code 119 - Identity Theft Detail (Profiles)
Identity Theft Custody cases			
Utilities only	SHR-49 URN 11	Station/Unit Detectives A	Handle accordingly. Code 118 - Identity Theft Detail (Utilites)
Identity Thefts (All others)	SHR-49 URN 11	Identity Theft Detail A	During business hours-immediate notifications to Fraud Unit. After business hours, weekends and holidays-notify Sheriff's Headquarters Bureau. Code 117 - Identity Theft Detail (Goods/Services/Credit)
Identity Thefts (Reasonable Cause Arrests)	SHR-49 URN 60	Identity Theft Detail A	Non Utility case/Immediate notification to Fraud Unit - Identity Theft Detail or Sheriff's Headquarters Bureau after hours. Code 609 - Reasonable Cause Arrest (All Other Felonies)

Identity Thefts where crime undetermined and "Suspicious Circumstances"	SHR-49 URN 44	Identity Theft Detail or Station/Unit Detectives A	Document nature of identity compromise based on information available from victim. If act involves utilities, refer to section marked "utilities" for assignment. Code 444 - Suspicious Circumstances, Possible Criminal Activity
Identity Theft involving fraudulently obtained vehicles	SHR-49 URN 11	Identity Theft Detail A	Station/Unit detectives MUST verify with dealer vehicle fraudulently obtained via means involving Identity Theft. If LASD jurisdiction, prepare CHP-180 and enter into SVS. Prepare supplemental report of facts and REASSIGN to Identity Theft Detail. If outside LASD jurisdiction, do not enter into SVS. Forward case to proper law enforcement agency for follow-up investigation and SRD to Identity Theft Detail. NOTE: "SRD" Identity Theft Detail Code 117 - Identity Theft Detail (Goods/Services/Credit)
Identity Theft involving "Attempts"	SHR-49 URN 11	Station/Unit Detectives P	All cases involving attempts will be documented. If outside LASD, refer to proper agency. NOTE: "SRD" Identity Theft Detail Code 119 - Identity Theft Detail (Profiles)
Identity Theft (Possession of Profiles) 530.5(a) PC	SH-R-49 URN 11	Identity Theft Detail A	Code 119 - Identity Theft Detail (Profiles)

Confidential	URN 44		Assigned by appropriate Bureaus only. Files shall be maintained by the individual Bureau. Report retention period to be assigned by Bureau.
Routine	URN 44		Assigned by appropriate detail only. These codes are for use by details for routine types of investigations other than assigned crimes or arrests. Examples: Pawnshop investigations, business license investigations, inspections, gun sale investigations, etc. Report retention period to be assigned by detail. Individual files or records of these activities may be kept at the detail or filed at the Records and Identification Bureau.
Special	URN 44		To be assigned by appropriate Bureau or detail only. Individual files may be kept as confidential by the Unit concerned. Report retention period to be assigned by appropriate Bureau or detail. This category is intended for non-routine, extensive investigations where no specific crime or arrest for a crime in our area is being investigated or reported. Code 441 - Special Investigation.
